2. A completed and signed copy of this certification form.

Please submit this completed form along with supporting documentation by email, fax or mail. If you are submitting by email then you must use your MassBay student-assigned email address. By using your MassBay email address you are protecting your identity. If you decide to email us your documents using a non-MassBay email address then you must encrypt your file.

- Certificate of Naturalization (N-550 or N-570) Issues by the USCIS
- A certificate of Citizenship (N-560 or N-561)

- A wallet-sized passport card
- A copy of Form FS-240(Consular Report of Birth Abroad), FS-545 (Certificate of birth issued by a foreign service post), or DS-1350 (Certification of Report Birth.)

Eligible Non-Citizenship Documentation:

- A permanent U.S. resident with a Permanent Resident Card (I-551)
- A conditional permanent resident with a Conditional Green Card (I-551C)
- The holder of an Arrival-Departure Record (I-94) from the Department of Homeland Security showing any of the following designations: "Refugee," "Asylum Granted," "Parolee" (I-94 confirms paroled for a minimum of one year and status has not expired), T-Visa holder (T-1, T-2, T-3, etc.) or "Cuban-Haitian Entrant;" or
- The holder of a valid certification or eligibility letter from the Department of Health and Human Services showing a designation of "Victim of human trafficked.
